

## INFORMATION ABOUT OUR GOVERNING BODY(GB)

**Manby Lodge has a total of ten Governors:** three elected Parent Governors, one elected Staff Governor, four Co-opted Governors appointed by the Governing Body itself, one Local Authority Governor and the Headteacher.

**Normally, there are four Full Governing Body (FGB) meetings in the academic year** – two in the autumn term, the first of which is a business meeting for the year, and thereafter termly. However, for the year 2019-20 there were six Full Governing Body meetings and Committee meetings were suspended, all business being carried out with all Governors at FGB through the pandemic emergency. All Governors are expected to attend FGB meetings; however with the best will in the world it is not always possible. In that case, Governors tender apologies for the meeting, which must be heard and accepted by the Governors. Attendance given below is for the academic year July 2019 – September 2020

**The two Committees – Children & Learning and Resources – normally meet termly, three times a year, but with the pandemic emergency all meetings from March were of the full FGB.**
